



BEWG has been selected as a constituent of the Dow Jones Sustainability Index

(Hong Kong, 13 December, 2022) On 10 December, 2022, S&P Dow Jones Indices announced its 2022 review results. With its outstanding performance in environmental, social and governance (ESG) performance, Beijing Enterprises Water Group was included in the Dow Jones Sustainability Indices for the first time and qualified as a DJSI-Emerging Markets constituent of the Dow Jones Sustainability Indices. The adjustment will officially take effect as of 19 December, 2022.

The Dow Jones Sustainability Index is the best-known and most trusted ESG investment index with the longest history provided by S&P Dow Jones Indices, one of the world's leading index providers. Since its launch in 1999, It has always conducted comprehensive measurement of global large companies based on economic, environmental and social benefits. Based on the Corporate Sustainability Assessment (CSA), it has adopted strict criteria to evaluate more than 10,000 listed companies in the world from three aspects of environment, society and corporate governance, and selected enterprises with excellent sustainability from them as its constituent shares.

The inclusion in the Dow Jones Sustainability Index indicates that BEWG has been recognized by the international capital market for its achievements in the field of sustainable development, which further enhances the influence and attention of BEWG in the international capital market, and is conducive to attracting more incremental funds and social capital for the Group in the capital market to promote the sustainable development of the Group.
